2026 Budget

Roland reviewed the Proposed 2026 Budget. There were no questions and the 2026 budget was accepted. The 2026 assessment will be \$525.00. Lots of spirited discussion from various residents as to why the dues have gone up. Explanation was provided but not universally accepted. Question on what can be cut from the budget to keep costs down. Possibly flowers can be reduced.

Election — Roland asked if anyone was interested in adding their name to the ballot. There were no volunteers. Roland Myers, Ginger Sack, Dan Harmon, Mike Secor, Adriane Oifoh, Kevin Wildermuth, and Lesley Lee were re-elected to their positions.
